1. AIQS POSTNOMINALS

Members who are allowed to use the postnominal appropriate to their membership grade are as follows:

- Honorary Fellow: FAIQS (Honorary)
- Life Fellow: LFAIQS
- Fellow grade: FAIQS
- Member / Associate grade: MAIQS / AAIQS
- Retired: add (Ret.) to the end of your postnominal. For example, MAIQS (Ret.) / FAIQS (Ret.)

Student and Graduate grade members are not entitled to use postnominals.

Lapsed members are no longer members of AIQS and are not entitled to use AIQS postnominals in any way or in any material. They may not claim to be members of AIQS in their Curriculum Vitae, any social media platforms, resumes, promotional materials, tender documents, fee proposals or any other written works including business cards and letterhead.

The following rules apply to the use of AIQS member classification and postnominals:

All AIQS members must clearly identify their grade of AIQS membership when shown on any form of marketing/promotional material including business cards, corporate website profiles and any social media platforms including LinkedIn, Twitter, and Facebook.

- Honorary Fellow can state: Honorary Fellow of Australian Institute of Quantity Surveyors
- Life Fellow can state: Life Fellow of Australian Institute of Quantity Surveyors
- Fellow can state: Fellow of Australian Institute of Quantity Surveyors
- Member/Associate can state: Member grade member of Australian Institute of Quantity Surveyors
- Affiliate can state: Affiliate member of Australian Institute of Quantity Surveyors
- Graduate can state: Graduate member of Australian Institute of Quantity Surveyors
- Student can state: Student member of Australian Institute of Quantity Surveyors
- Retired can state: Retired (insert relevant grade) member of Australian Institute of Quantity Surveyors

2. CERTIFIED QUANTITY SURVEYOR DESIGNATION POSTNOMINALS AND TITLE

The CQS designated members are entitled to use the postnominals CQS. For example, a Fellow with CQS designation is to be shown as FAIQS, CQS.

CQS designated members are entitled to call themselves a Certified Quantity Surveyor.

3. AIQS VOTING MEMBER LOGO - INDIVIDUALS

The following Voting member grades are entitled to use the AIQS Voting member logo:

- Life Fellow
- Fellow grade
- Member grade

Affiliate, Student, and Graduate grade members are not entitled to use the AIQS Voting member logo.

The AIQS member logo must be the current logo available on the AIQS website (www.aiqs.com.au) or upon a request from the member via an email to marketing@aiqs.com.au.

The AIQS member logo can be used for marketing purposes.

The AIQS member logo or the AIQS name must not be used in any way to imply AIQS endorsement of any specific product or service.

4. AIQS VOTING MEMBER LOGO – FOR COMPANIES

The AIQS member logo may only be used by a business where more than 50% of their quantity surveying staff are Voting members of AIQS. The AIQS member logo can be shown on the company's website and marketing collateral. Student or Graduate members do not count in this calculation.

When an eligible business uses the AIQS member logo the following words must be shown under the logo: "50% or more of our quantity surveying staff are AIQS Voting members."

Where businesses are eligible to use the AIQS member logo and a staff member who is not an AIQS Voting member contravenes the AIQS Code of Conduct or is brought into disrepute in any way, the staff's supervisor, or whoever is most senior AIQS Voting member in that business, will be held accountable.

5. CERTIFIED QUANTITY SURVEYOR LOGO

CQS designated members are entitled to use the AIQS CQS member logo for their individual marketing purposes.

The AIQS CQS member logo must be the current logo available on the AIQS website (www.aiqs.com.au) or upon a request from the member via an email to marketing@aiqs.com.au.

The CQS logo may only be used by a business where 100% of their quantity surveying staff have achieved CQS designation.
